

# Mid-Town Hospital

## Neutrality Agreement

The following doctrine shall serve as a statement of Neutrality of all Medical Staff whether or not they are assigned to Mid-Town Hospital or any affiliates, hereinafter referred to as “Mid-Town Associates”. This Agreement constitutes an exclusionary contract of protection to any and all Mid-Town associates, staff, and locations provided they are announced as or discovered to be as such.

# Mid-Town Hospital

## Neutrality Agreement

### Basic Statement of Neutrality

Mid-Town Hospital (site location) shall be considered neutral territory under all circumstances, combat- or combat-related or otherwise, where forces hostile to each other or anyone in Mid-Town shall be subject to sanctions up to and including permanent revocation of services (location and off-site) by Mid-Town personnel to the violating party, group, or association, and referral to the Provincial Judiciary for further sentencing.

Any Mid-Town associate providing care of any sort shall do so humanely, without any discrimination against someone's race, color, religion, affiliation, social or political association, sex, gender, or any lack thereof in the aforementioned categories.

# Mid-Town Hospital

## Neutrality Agreement

### Applicable Locations

Any location where official Mid-Town staff are providing care shall also be recognized as a neutral location, in the same manner as if they were on-site at Mid-Town. They shall be made known by a visibly displayed Gold Shield patch and/or Mid-Town-issued blue field boots if providing field care during City Duty rounds.

# Mid-Town Hospital

## Neutrality Agreement

### Limits of Protection

**This order shall not protect Mid-Town associates if they are performing duties for any faction, identified or unidentified, that violate the included stipulations. Mid-Town associates that demonstrate affiliation for one combative party to the exclusion of any other person, party, associate, or group shall void any protections provided by this Agreement.**

# Mid-Town Hospital

## Neutrality Agreement

### Detention of Mid-Town Associates

Should a party or their contacts up to and including their employer, either actual or by proxy, engage in the following acts, they will be deemed to be in violation of the Neutrality Agreement:

- 1.To knowingly detain a previously known or identified as Mid-Town associate through verbal acknowledgement or visible inspection of Gold Shield identification without prior exclusionary contract
- 2.To knowingly transport a previously known or identified as Mid-Town associate through verbal acknowledgement or visible inspection of Gold Shield identification outside the borders of the Province without prior exclusionary contract
- 3.To incarcerate knowingly a previously known or identified as Mid-Town associate through verbal acknowledgement or visible inspection of Gold Shield identification

# Mid-Town Hospital

## Neutrality Agreement

By permission of the Board and/or acting Administrative Officer or their designee, access to Mid-Town Hospital will be restricted up to and including banning for a set period of days, enforceable by contracted and identified agents of the Board, the Administrative Officer, or their designee.
